4.CHAIRMAN’S UPDATES AND MATTERS ARISING

The re- planting of the planters at the shop frontage has now been completed, Little Hoole Parish Council are now responsible for their maintenance.

Spar has agreed to sponsor the planting on the right side of Walmer Green Gardens.

Item 9 – Outdoor Gym Equipment was then discussed .  
Councillor J Rainsbury advised that a licence and official permission are required and these have been requested.

## Item 11- Walmer Bridge Village Hall Extension

They plan to add a disabled toilet, re-do the whole of the toilet block but not to extend it.

The kitchen area will be moved into the foyer in order to make better use of the space available.

It was agreed to pay Hoole St Michael Church £350 for maintenance of the burial ground.

It was agreed to pay £150 in respect of the Methodist Burial ground.

### Walmer Bridge Village Hall

Following the information received earlier in the meeting under Item 11, it was agreed that a sum of £25,000 be allocated for work on the Village Hall. This was in anticipation that the work be completed before the end of our financial year 31<sup>st</sup> March 2019.
